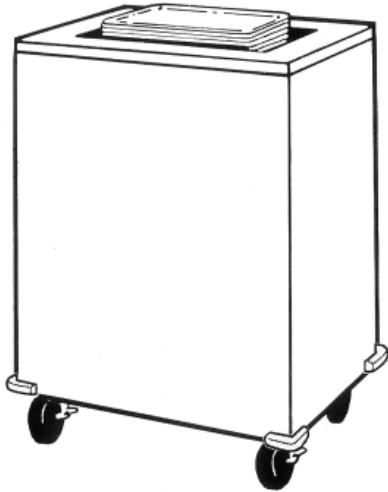

The unit is mounted on four 4" diameter heavy duty, double ball bearing, swivel casters with non-marking rubber tires.

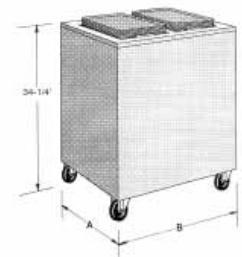
